1. Request nominations NLT 17 December 2018 for the position of Command Surgeon, U.S. Southern Command.

2. The incumbent Surgeon begins terminal leave on 1 April 2019. In order to ensure continuity, the desired report date to HQ, USSOUTHCOM, Doral, FL is 11 March 2019, or as soon as practicable.

3. The Command Surgeon directs medical operations and health service support of combat and contingency operations. Plans and executes medical operations, programs and events in support of the Commander's Strategic and Theater Security Cooperation Plans. Exercises technical staff supervision over Component, Sub-unified, Joint Task Force and Joint Interagency Task Force Medical activities. Collaborates with interagency partners, international organizations and non-governmental organizations to carry out medical activities in the AOR. Engages personally with host nation defense force Surgeon's General and Ministers of Health to develop medical security cooperation strategies and activities


4. Candidates must be physicians in the rank of O-6 and eligible for a Top Secret security clearance with Secured Compartmented Information access. It is desired that candidates have previous experience in a joint/combined environment and future promotion potential. Fluency in Spanish is preferred due to engagement with partner nations.
