## Naval Medical Readiness Criteria Development

Naval Medical Readiness Criteria (NMRC) development efforts continue to progress through stakeholder feedback and annual requirement revalidation

### NMRC Development Updates:

- Validated 248 DON Tracker comments on 85 NMRCs
- Routing 44 Phase II NMRCs for Surgeon General signature

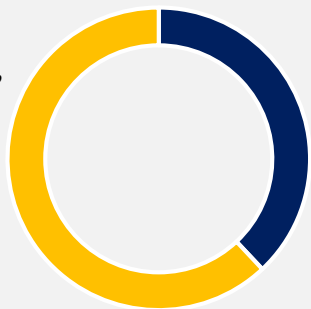
### NMRC Revalidation Updates:

- Revalidated requirements for 16 of the 41 Phase I NMRC
- Remaining 25 Phase I NMRC expected to be revalidated by JAN 2021

## NMRC Medical Service Corps Development Efforts

NMRC validation efforts are **ongoing for specialties within the Medical Service Corps**, with the help of Specialty Leaders (SLs), the Office of the Corps Chiefs, and subject matter experts (SMEs).

- 4 Medical Service Corps specialties are visualized in the NKSA Proficiency Dashboard

## Map to Success - Platform Leaders and the NMFDC

The responsibilities for Platform Leaders summarized below are included in the *Naval Knowledge, Skills, and Abilities Process and Readiness Criteria Implementation Memorandum* and support the Surgeon General's priority of Naval Medical personnel meeting and exceeding their operationally focused KSAs

### CONFIRM

Platform Leaders confirm the completion of Naval Medical Readiness Criteria of all subordinate personnel

### OVERSEE

Platform Leaders provide oversight with NMRTC/U leadership to certify personnel compliance with readiness metrics prior to deployment

### COORDINATE

Platform Leaders coordinate and ensure all unit personnel are tracked and current within authoritative data systems

### AUTHORIZE

Platform Leaders exercise ultimate authority to determine unit readiness condition
