Naval Medical Readiness Criteria Phase Update



Phase I

Revalidation

- 28 of 41 NMRC that were signed by the Surgeon General have been revalidated
- On 06 JAN 2021, the final revalidation telcon was held for Specialty Leaders (SLs) to provide additional support and answer any questions or concerns regarding the revalidation request



Phase II

Development

- 44 NMRC have undergone enterprise-wide review by stakeholders, entered into DON Tracker on 16 DEC 2020 for SG approval and signature
- Validated 248 DON Tracker comments on 85 NMRCs



Phase III

Planning

- 37 NMRC development is planned to kick-off in JAN 2021
- Preparing quarterly updates for Office of the Corps Chiefs and NMRC telcon materials prior to the Phase III kick-off

December Stakeholder Engagement Session

On 17 DEC 20, the NMFDC held a stakeholder engagement session to address gaps in support of an operationalized NKSA Proficiency Dashboard and identifying actions to mitigate and/or improve current challenges in clinical currency attainment and sustainment. Key session takeaways include:

- Provided insights on readiness decision making responsibilities
- ✓ Discussed the role of leadership at Navy Medicine Readiness and Training Commands (NMRTCs) and Military Treatment Facilities (MTFs) in improving the ability to track requirements at the deckplate, and the need to mitigate readiness gaps between MTFs and operational platforms
- ✓ Reviewed known gaps in the NKSA Proficiency Dashboard data, including non-trackable courses, and discussed mitigation strategies currently used (e.g., Smartsheet app for On the Job Training) or others that could be used in the future

Gained consensus that a fully operational NKSA Proficiency Dashboard can be used in the following ways:

- Identify what courses need to be developed
- Determine where to utilize partnerships
- Review regional readiness especially for Tier 1 platforms
- Provide a clear understanding of providers' certifications
